During the 2016 year seven women vets and six children were assisted through this program. We also provided 1,614 days of housing.

4b (Code:) (Expenses \$ 103781. including grants of \$) (Revenue \$) The S.A.F.E program provides valuable financial education resources on saving, budgeting and living on a fixed income. S.A.F.E provides emergency financial support by assisting with past due rent, security deposits and utility assistance. Residents of our H.O.M.E program are also required to participant in the financial education components of our S.A.F.E program. Throughout 2016 The S.A.F.E. Program assisted 37 women vets and 66 children; in addition we provided financial education documents and resources to 377 women vets and 595 children.

4c (Code:) (Expenses \$ 20477. including grants of \$) (Revenue \$) The Stand-Up for Women Vets program provides support for women Veterans and military women in transition to the civilian workforce. We provide free of charge: Professional Business Attire, Dress Shoes, Accessories, Make-Overs, Image Consulting, and Professional Head-Shots.
